2. Most confusing piece about Program Review process... or a question that I've always had about Program Review.

Response:

- "Do I have to do it?" Some programs have been around for years and have not engaged in the process.
- Program Review software (many perspectives on this point); both TracDat and SPOL
- Why are we doing all of this
- The goals from the college are not necessarily tied to the resource request (you might get it, you might not, but you'll have a chance to reflect on the program)
- The software and resource allocation requests and yet resource requests get lost multiple time in multiple instances and then we just have to figure out resources on our own.
- The resource request process is very confusing; unclear if the request is for staffing, supplies, etc.; policies and connections are not clear
- Why are we doing this if it's not connected to funding (should differentiate between an annual report and the resource request)
- Personnel resources and then technology requests are very confusing
- The connection between Program Review and Resource Requests is not clear; the content part for Program Review was easy – everything else was complicated.
- Where does technology fit in? It's confusing – should I request it, should I not request it, does it not belong in this process?

- Should grant programs submit program review and resource requests?
- Deadlines are confusing; even when they are set to be more clear they change and its confusing
- Evaluation of resource requests has been challenging and confusing, especially for resources that are not necessarily personnel; which bodies provide feedback for resource

Clarifying questions:

1. How have we heard about other programs in their reviews and do we need to change how we do it now? Presenting for 3 – 5 minutes is not worthwhile for both hiring and program review. Could it be a campus wide event with Instruction and Student Services?
2. How do we get to know each other, programs and services better? What about having a college hour?
3. In a perfect world, I'd love for Program Review to...
 - Require program review for every program on a 3 year cycle; every 6 years, a program should be required to provide an in-depth (Max will email feedback)
 - Program Review feels different for Student Services than it does for Instruction; highlighting our programs really helps us to better serve our students; can Program Review be more streamlined to what Student Services does with and for students; still feels like we are a square peg trying to fit into a round circle with prompts that are built for Instruction; can we update the prompts to reflect more of Student Services
 - Program Review would not be a one size fits all model; many of the requirements don't fit the need that we have in Student Services (EOPS, Personal Counseling, Health Center, etc.)
 - Would love Program Review to look like a Google Doc in which I can see live edits and comments from experts and other staff over time; this insight would be very helpful for our student leadership lens and having students involved
